- 1. Call to Order and Pledge of Allegiance:** Meeting was called to order at 6:30pm by Kurt Youland, with the Pledge of Allegiance being said. Present: Steve Maheu, Kevin Nichols, Kurt Youland, Warren Hood, Angelo Terreri, Kurt Schaub, Lisa Bennett, and Nathan Gupstill.
- 2. Adjustments to the Agenda:** No adjustments
- 3. Town Report Bid: 3-1: Review Bids:** Received three bids: Snowman Group, Walch Education/Printing and Xpress Copy. **3-2: Award/Action as Warranted:** Motion and second to award bid to Snowman Group up to \$2,782.34 with Kurt Schaub reaching out to Snowman Group to get a lower price, 3 in favor, 2 opposed.
- 4. Rescue Department Report: 4-1: Regular Monthly Report:** Had 50 calls in the month of February, bringing the year to date total 148 calls. Medical supply costs have increased drastically. Lisa is trying to get some supplies from EMS. Lisa would like permission to purchase the P.L. Custom truck for \$8,000, to eventually mount the P.L. custom box onto the chaise of the AEV ambulance and put the AEV box out to bid. **4-2: Action as Warranted:** Motion and second to approve the purchase of the P.L. Custom Ambulance for \$8,000, unanimous vote.
- 5. Fire Department Report: 5-1: Regular Monthly Report:** For the month of February had a total of 6 calls. Held an ice water rescue training. Received two quotes for garage doors on from International Door Company in the amount of \$11,967 and from D&N Sales in the amount of \$10,364. **5-2: Action as Warranted:** Motion and second to approve purchasing the doors through D&N Sales, unanimous vote.
- 6. Town Manager's Report: 6-1: Financial Statements:** Most current statements were provided to the Board for review. **6-2: Town Meeting Warrant/Other Considerations:** A draft Warrant was provided for review. Kurt Schaub has contacted Maine Municipal; Association for advice should the board determine it's in the town's best interest to postpone the meeting. At present there is a 50 person limit on indoor gatherings, and a 100 person limit on outside gatherings. Motion and second to move Town Meeting date from April 9th and 10th to May 21st and 22nd, 3 in favor and 2 opposed. **6-3: Road Posting Order:** Motion and second to approve Leland Searles to post roads, unanimous vote. Suggestion was made to purchase gravel instead of skimming it for summer roads, as not a lot of gravel will be needed this summer to complete planned projects. Currently have \$37,000 in that budget. Motion and second to spend up to \$37,000 for culverts and gravel, unanimous vote. **6-4: Planning Board Public Hearing – Marijuana Ordinance:** The Planning Board will hold a public hearing on its draft Marijuana ordinance at 6:00pm on Wednesday, March 3rd at the Town Office. Bill Bullard has been

advised that he may want to be prepared for other arrangements if enough residents turn out so that social distancing becomes undoable in the Town Office meeting room.

7. **Consent Agenda:** Motion and second to approve the consent agenda, unanimous vote.
