- 1. Call to Order and Pledge of Allegiance: Meeting was called to order by Kurt Youland at 6:30pm and the Pledge of Allegiance was said. Present: Steve Maheu, Kevin Nichols, Kurt Youland, Angelo Terreri and Kurt Schaub. Absent: Warren Hood
- **2.** Adjustments to the Agenda: No adjustments.
- **3.** New Business: **3-1**: December 18th Storm FEMA Claim: Turner's claim to FEMA for the December 18th storm has been submitted, current estimate of damages now stands at a little over \$52,000.00. **3-2**: Maine EMS Stabilization Program: Table until Rescue Chief, Lisa Bennett is present to discuss.
- 4. Old Business: 4-1: Fortin Drive Drainage Complaint: Board feels the town is not responsible for the culvert as it is a private road. 4-2: BQMC Renovations: A draft floor plan was presented to the Board for the renovations contemplated for the BQMC Hall. After reviewing the draft floor plan, Kurt Youland will look at some options for flooring, and fixtures to bring back to the board to look at.
